MEMORANDUM

Miss Nimisha Baruah is hereby offered appointment as Project Assistant (PA) to work under the All India Coordinated Research Project titled "All India Coordinated Research Project on Bamboo [AICRP-2]", Principal Investigator: Shri Mohd. Ibrahim, Scientist-D of Genetics & Tree Improvement Division of Rain Forest Research Institute as per terms and conditions mentioned below.

1. The stipend of PA will be Rs. 15,500/- (Rupees fifteen thousand five hundred only) per month. The appointment of PA is Co-terminus with the project.
2. The appointment does not imply any assurance or guarantee for subsequent employment in any Institute/ Centre under ICFRE. ICFRE has full right to award/ terminate the Fellowship.
3. The stipend of PA is exempted from the payment of the income tax.
4. Any kind of paid or honorary, part or full time employment or private even in honorary capacity is not permissible during the tenure of fellowship.
5. A PA is eligible to claim TA / DA as admissible to the official of RFRI drawing the same salary in accordance with the rules of the Institute for any tour undertaken by her during the tenure of the fellowship.
6. A PA is eligible only for 8 days Casual leave for each completed year of tenure. The participation in any scientific event/workshops in India or abroad will be treated as on duty. No carrying over the leave to the next year is permitted. Sanction of leave without stipend may be considered by the Director of the Institute under special circumstances. In case PA proceeds on leave before termination of Fellowship he/she must join back before the expiry of tenure, failing which the tenure will be deemed to have terminated with effect from the date he proceeded on leave.
7. The appointment will be -
a. Co-terminus with the project
b. Can be terminated in case the concerned Supervisor is not satisfied with the progress of work.
8. An amount of Rs. 5,000/- (Rupees Five thousand) only will have to be deposited in the account no. 50100210620942, Director, RFRI, HDFC Bank, Jorhat, IFSC-HDFC0006753 at the time of joining as Caution Deposit which will be forfeited, if he/she leaves the fellowship without prior intimation before one month to the undersigned.
9. The PA has to work in the project sub-component titled "Selection, evaluation and development of CPC's clones, establishment of rhizome banks and production of improved planting stock" at RFRI, Jorhat.

If, Miss Nimisha Baruah accepts the offer on the above terms and conditions he/she should report to the Director, RFRI, Jorhat on or before 12.03.2020.

No travelling allowance will be allowed for joining.
