Applications cum Sealed Tender Papers are invited from interested person(s) for running the college Canteen on or before 20<sup>th</sup> February, 2022. Interested persons may collect the authorized Applications cum Tender Papers from the office of Bahona College during office hours from 7<sup>th</sup> of February, 2022 till 19<sup>th</sup> February, 2022 buy paying Rs.10/- (Rupees Ten) only. Terms and conditions are mentioned below.

### Terms and Conditions:

1. The applicant must have a Food Menu (Approved by College), Refrigerator, Coffee Vending Machine, Oven/Microwave, Dinner Set and crockery set.
2. The party must have online transaction facilities. (PayTm/BHIM/UPI etc)
3. The selected party has to deposit an amount of Rupees Twenty Thousand (Rs. 20,000/-) only as security money to the college.
4. The party has to pay the electricity bill and rent on or before 10<sup>th</sup> of every month.
5. The party has to clean and maintain the canteen and its surroundings.
6. The party has to make arrangement for disposal of garbage by themselves.
7. The party should not damage or destroy any movable or immovable property of the college.
8. The party should not damage the reputation of the college.
9. The party has to serve healthy and hygienic food in the canteen.

10. The party has to open the canteen even in holidays if authority orders. The party has to open the canteen in summer break, winter break, and in slack and lean season.
11. The party has to take prior approval for keeping the canteen closed on working days. A fine of Rs 100/- (Rupees Hundred) only per day will be charged for not opening the canteen on irrational ground.
12. The party has to supply food items for practical examinations even if requested for 2/3 persons.
13. The canteen will be leased for three years subject to satisfaction of their services.
14. College may cancel the lease at any time if the party fails to run the canteen as per terms and condition mentioned above with a one month prior notice.
15. College will return the security money to the party after the completion of the tenure with interest, if the party runs the canteen without any objection for the leased period.
16. The party will be fined for destroying or damaging properties of the college.
17. The party has to collect a FSSAI certificate after starting the canteen
18. The selection will be based on the following method:
  - A. Monthly Rent: 35% (Highest rent bidder will get maximum score and others will get relative score)
  - B. Food Item Price Menu: 35% (Lowest price bidder will get maximum score and others will get relative score)
  - C. Preference Condition Score: 5 points for each (only with valid documents)
